LTS product safety media release 29/9/17 - editors notes:

- 1. London Trading Standards (LTS) represents the 33 local authority Trading Standards services in the London Region. We share information and awareness campaigns across the capital to protect consumers and safeguard legitimate enterprise.
- 2. Our members advise on and enforce laws that govern the way we buy, sell, rent and hire goods and services. We carry out inspections and monitor or investigate complaints. We endeavour to work with businesses to help achieve compliance but ultimately we can prosecute those who break the law. Trading Standards have the power to inspect premises involved in the distribution of used electrical goods. They may suspend and seize goods as appropriate as well as conduct investigations into criminal offences arising from unsafe goods

- 4. Unsafe electrical goods have the potential to kill or injure so there are rigorous safety regulations concerning the supply of both new and second-hand electrical equipment. These place responsibilities on manufacturers, importers into the EU, and distributors, such as retailers. Under the General Product Safety Regulations 2005 there is a legal requirement that all second hand electrical goods supplied by businesses, including landlords and property agents, are safe.
- 5. Businesses found to be non-compliant means they have not complied with the law outlined in point 4 above ranging from minor issues such as labelling, to electrical dangers or absence of warnings/instructions for use.
- 6. In February 2016 a report was published, following an independent review lead by Lynn Faulds Wood, which looked at how the UK's system for the recall of unsafe

products could be improved. https://www.gov.uk/government/publications/consumer-product-recall-review

- 7. Following on from the Shepherds Bush fire in 2016 which was found to have originated in an Indesit tumble drier subject to a safety notice, the Minister for Small Businesses, Consumers and Corporate Responsibility set up a working group to look at Product Recalls and Safety. This recommended a more robust recall system and more stringent registration and traceability so that items found to be unsafe could be more easily identified and removed from the supply chain.

 - Day 4: Support for Businesses, to help businesses to survive, thrive and grow
 - Day 5: Product Safety, to help prevent people being killed by unsafe domestic goods
